471 Police Matters

No official correspondence received from the Police. However, there have been posts on Social Media regarding anti-social behaviour and a missing teenager. The Police have also been out knocking on doors in Lochinvar regarding this

472 Reports from Representatives on Other Bodies

Longtown Community Centre Board of Trustees – Cllr Sir JFS Graham

- There is an £80k grant for upgrading the community centre
- A meeting for this is arranged for the end of this month

Allotment Committee - Cllrs M Gunson and C Adams

- Most of the empty plots have now been filled only a couple more to allocate
- The 'waiting list' has nearly been cleared
- Now offering 'half' plots
- Concerns over new and existing tenants that have not started to tend to their plots yet
 - To be investigated
- There is a shed on site that contains asbestos. The doors to this were padlocked to prevent access. The original padlock had been taken and signs of people entering.
 - o New padlock has been secured and keeping an eye on this
- National Allotment Society has requested a list of allotment tenants
- Plots should now be 'pay per person' and not 'per plot'
 - Cllr M Gunson to seek legal advice on this

CAP Iniative – Cllrs G Routledge and C Johanssen

• Endless emails have been sent; however, no response has been received

Incredible Edible - Cllrs C Johanssen and M Gunson

- CJ and MG to have a discussion about trying to link this with the allotments
- Strawberry beds are coming along nicely
- Dwarf French beans, spinach and radish seeds have been sown
- Cllr M Gunson suggested re-naming this project to 'Village Veg' was agreed to action this

Borderlands Project - Cllr M Gunson

- Meeting held on 14th May 2024 with councillors and local people present
 - This was held to look at the communications plan which is being drafted by Cumberland Council
 - Once the communication plan is finalised it will be issued to the public
 - Next meeting is on the 10th July 2024

Borderlands Project – Community Representative Cllr C Johanssen

- Draft communication plan sent to councillors
- It is felt that there is good vision on this with lots of projects
- More clarification to be sought on this

 - Suggested sites:- Netherby Road, Hope site cross roads, How End, the Island

 - RFO agreed to follow this up

483 Report from Cllr T Pickstone

"Just to let you know that I cannot come to the Parish Council meeting tonight. I was hoping to be there, but you will understand that the General Eleciton is getting in the way of a lot of things.

A few things from me:

- all is going well with the two biggest areas of work for me in Longtown, around the Borderlands Project and the Community Centre. Margaret and James will be able to report back directly.
- I have raised with Highways the continuing extremely poor state of the road surface on Mary Street / Moor Road. This is being reviewed again.
- Residents have raised with me the poor state of the footpath on Arthuret Road. Initially this work was refused by the Council as 'not needed', but I have asked them to review this situation.
- There is a major set of planning applications in the system which will be of interest to Longtown around Hespin Wood (making the waste processing facilities permanent, not temporary). This wont progress quickly, so I should hopefully be able to explain more to you at the July meeting."

- Suggested that the 'Friends of Arthuret Group' be set up again to care for the ancient well near Arthuret Church
 - o Agreed to discuss with the Perochiel Church Council
 - o RFO to put in a bid for grant
